On May 9, 2012, Servant Cab Company LLC, of Lincoln, Nebraska, filed an application for authority to amend its fuel surcharge taxi rates for transportation between points in Lincoln and a 25 mile radius thereof as follows:

Applicant is a certified common carrier which holds Certificate B-1581. The Certificate authorizes the transportation of passengers by taxicab between points in Lincoln and a 25 mile radius thereof.

On June 19, 2012, the Commission entered an order granting Informal Intervenor status to Happy Cab Company, d/b/a Happy Cab, Happy Cab Company, d/b/a Checker Cab, Happy Cab Company, d/b/a Yellow Cab, and Valor Transportation, d/b/a Safeway Cab. The Commission heard testimony on this application during the hearing on Application No. B-1581, Supplement 1, held on June 19, 20, and 21, 2012.

OPINION AND FINDINGS

The basis for this application was Application No. B-1581, Supplement 1. That application sought the extension of the Applicant's authority to all areas of the state except for those areas already served by a taxi authority, except for Douglas, Sarpy, and Washington Counties.

The Commission entered an order on August 21, 2012, that denied Application No. B-1581, Supplement 1. The underlying basis for this application is, therefore, moot, and the Commission finds that the Application should be dismissed.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. TR-191 is hereby dismissed.
